Chair's Report

As circulated

Treasurer Report

Accumulated fund increased from 2009-10 - £4646.74 to £5282.72. Surplus was £635.98, down from £874.61 last year but similar to 2008/9.

Current Lloyds TSB account balance \pounds 2914.58. The Britannia Building Society balance \pounds 2576.31 with very little interest earned (\pounds 2.06). Combined total is \pounds 5490.89

Key points:

- $\circ~$ Team & Player Registrations amounted to £1010, which included additional player registrations/fines of £276.
- $_{\odot}$ $\,$ EDVA Mens and Ladies Tournaments made a surplus of £121.76 in total
- \circ Beach League produced a much lower income of £374.43 compared to income of £661 in the previous year. With expenditure running at a similar level to the previous year of £343.59, the League was only just in surplus at £30.84
- Asset value of capitalised purchases: beach ropes, beach nets, Exeter School replacement net, have now reduced to an asset value of £41.83 as a result of annual depreciation amounts in the balance sheet. This will be cleared next year
- Goodwill deposits increased to £250.00.

EDVA Rule Changes

Proposed Supplementary Rule Changes

The intention of the following rule changes is to distribute the work load across those involved in the league and make it more self managed, such that the work load on the fixture's secretary is reduced and increasing the longevity of the league.

The intention of the following rule changes is that each home team will be responsible for entering their own results and match reports on line and scanning their scoresheet and emailing then to the fixture secretary.

Current Wording

3.11 Home teams are required to complete a short match report using the space provided on the score sheet (and continued on the reverse of the score sheet where necessary). A fine of \pounds 2-00 will be levied for each occasion in which a team fails to provide an adequate match report.

Proposed Wording

3.11 Home teams are required to complete a descripted match report (no fewer than 25 words) in the report section of the online results entry form within one week. A fine of \pounds 5-00 will be levied for each occasion in which a team fails to provide an adequate online match report.

The meeting agreed to increase the fine to £5 and for the report to be a minimum of 25 words.

Current Wording

7.4 The home team will be deducted 1 league point for not returning a completed score sheet to the Fixtures Secretary within ONE week of the fixture being played. Proposed Wording

7.4 The home team will be deducted 1 league point for not entering their results online, electronic image of the completed scoresheet and emailing it (a minimum of 2 .jpgs for left and right hand side at 100dpi) to the Fixtures Secretary within ONE week of the fixture being played. The white copies must then be held by the home team until the end of the season in case of queries.

Proposed and agreed by all present.

Exeter College would like to propose the following amendments to the Supplementary Rules:

That Clause 3.5 be amended to read: "A fixture will be the best of five sets played according to normal EVA rules. If the outcome of the match has been determined after three sets, additional sets may be played at the discretion of the two teams."
